

GENERAL TERMS AND CONDITIONS

APPLICATION FOR YOUR JOURNEY

Purposeful Journeys reserves the right to decline an application to travel. Your complete application requires a decision on travel insurance. Your application and travel insurance decision shall be considered acceptance of all General Terms and Conditions. Malone Clan Expeditions, LLC reserves the right to refuse any application for any reason. Applicants will be notified of the acceptance or rejection of each application.

TRAVELERS REQUIRING SPECIAL ASSISTANCE:

Applicants should be aware that the law known as the Americans with Disabilities Act (ADA) does not apply beyond the borders of the United States and its territories. Facilities for disabled individuals are limited. Streets and walking surfaces may be centuries old and uneven in places. Travelers on a journey with Malone Clan Expeditions, LLC. Travelers shall be capable of walking moderate distances. Some journeys may include the ascent and descent of multiple flights of stairs.

Applicants requiring assistance or the use of any device to assist in mobility must disclose such need on the application. A physically able companion must accompany any person who needs special assistance in mobility. Tour guides, drivers, hotel, museum or other facility personnel or employees will not be required and will not be able or qualified to provide assistance to travelers with special needs. Malone Clan Expeditions, LLC shall not be responsible for any denial of services to a traveler with special needs by air carriers, cruise ships, hotels, restaurants or other independent suppliers. Travelers with special needs waive all claims in contract and tort against Malone Clan Expeditions, LLC.

REMITTANCE SCHEDULE AND PAYMENT OPTIONS:

Malone Clan Expeditions, LLC will publish a remittance schedule, payment options and terms to travelers who become members of journey. Payment in full must be received by the published date of Final Payment. Payment options, may include personal check, PayPal, Credit Card or other major credit card may be accepted as specified.

TRAVELER CANCELLATIONS:

Malone Clan Expeditions, LLC relies on the purchase of travel insurance by travelers to reimburse travelers who need or desire to cancel their journey. Travelers are advised to carefully consider their travel insurance decision as cash refunds are only issued travelers who cancel their journey with rare exception and at the sole discretion of Malone Clan Expeditions, LLC.

Travelers may decline to purchase travel insurance. Malone Clan Expeditions, LLC may offer Cancel-For-Any-Reason (CFAR) Aon NTA Travel Protect Insurance for about the cost of Basic NTA Travel Protection. To ensure successful purchase of a CFAR policy within the 14-day allotted time, Malone Clan Expeditions, LLC MUST enroll each fellow traveler in the NTA Travel Protection Plan. The application deposit will be considered paid by Malone Clan Expeditions, LLC when the payment for CFAR travel insurance option is either received by Malone Clan Expeditions, LLC or the travel insurance purchase is declined by the fellow traveler.

Malone Clan Expeditions, LLC reserves the right to cancel your journey reservation if final payment is not received by the Final Payment due date. Airline tickets are not refundable once your flight has been ticketed. No refunds or travel credits will be given for any unused goods, services, or activities while on the journey. All refunds will be issued after the conclusion of the journey.

ITINERARY CHANGES OR JOURNEY POSTPONEMENT:

In an unlikely circumstance such as a worldwide economic shutdown or global pandemic Malone Clan Expeditions, LLC reserves the right to modify your trip itinerary or postpone your journey. In the exceptional case of postponement, Malone Clan Expeditions, LLC will work to provide the fairest solutions in the best interest of all fellow travelers affected.

TRAVEL AND HEALTH INSURANCE:

Malone Clan Expeditions, LLC strongly recommends trip insurance. Insurance for trip cancellation, medical evacuation, medical emergencies, baggage, etc. may be available for purchase from multiple underwriters.

Please note that Medicare and many private health insurance companies may not cover healthcare or medical expenses outside of the United States. Please consult with your health insurance provider to obtain proper coverage for overseas travel.

PICTURES AND VIDEO:

Malone Clan Expeditions, LLC may take pictures and video during your journey. At the conclusion of the journey, members of the journey will have the opportunity to share pictures and videos with Malone Clan Expeditions, LLC and with their fellow travelers. By registering for this journey, you grant Malone Clan Expeditions, LLC permission to use your image and comments in educational, informational, and promotional materials in a variety of media, including electronic and social media.

THE PRICE OF YOUR JOURNEY INCLUDES:

SURFACE TRANSPORTATION: By deluxe motor coach or other conveyance as appropriate to your journey.

HOTEL ACCOMMODATIONS: Accommodations at hotels based on two persons sharing a room with private bath. A traveler requiring a single room (subject to availability) must pay a single supplement. Single rooms are limited.

MEALS: Breakfast daily (hot or cold buffet or full breakfast) and meals as indicated on the final itinerary.

SIGHTSEEING: Entrance fees as specified in the final itinerary are included with the services of guides based on need and availability as determined by Malone Clan Expeditions, LLC.

THE PRICE OF YOUR JOURNEY DOES NOT

INCLUDE: Air transportation (unless expressly included) Passport fees, visa fees (if any), hotel tourist taxes (to be paid locally), phone calls, valet/laundry service, wines, liquors, bottled water, after dinner coffee or tea, tips to wait staff, guides, drivers, sightseeing guides, meals and other services not explicitly included, excess baggage and all other items of a purely personal nature. are not included. Any goods, services, or activities not specifically mentioned herein as included in the price of the journey is hereby excluded. Travel insurance is not included.

DEVIATIONS FROM GROUP TRAVEL ITINERARY:

All deviation requests from the group itinerary must be received Malone Clan Expeditions, LLC in writing. A \$100 non-refundable fee per person will be charged on all deviations in addition to any extra airfare that may be incurred. Deviations in group air travel are subject to availability and restrictions as imposed by the airlines.

AIR TRANSPORTATION: Air transportation may be provided by any commercial air carrier. Flights may be booked and ticketed on bulk group rate basis when available as a non-refundable, non-changeable economy class ticket. Flights and air routes are the discretion of the air carriers. Written Traveler cancellations made after air tickets have been issued are subject to full cancellation penalties as imposed by the airlines.

Seat assignments for group air arrangements are made at the discretion of the airlines. Malone Clan Expeditions, LLC may endeavor to fulfill seat assignment requests, but cannot guarantee the airline will honor these requests. Malone Clan Expeditions, LLC endeavors to provide the lowest reasonable price for group journeys. Therefore, direct routes to and from final destinations are not guaranteed. Malone Clan Expeditions, LLC shall not be responsible if an airline cancels, reschedules or delays a flight for any reason. Malone Clan Expeditions, LLC will not provide any refund for portions of trips missed due to canceled, rescheduled or flights delayed by any carrier.

TAXES/AIRLINE SURCHARGES: U.S. departure taxes, overseas airport taxes, overseas and local government taxes, airline security fees and airline imposed international surcharges are included in the price of your journey at the time you are accepted as a member of a journey. Price increases may be applied to the Final Payment due to additional costs as imposed by a supplier or governments.

BAGGAGE:

As published in the policy of each air carrier, airlines may now charge baggage fees for checked luggage on international/domestic flights. Policies of each carrier may differ as to the maximum number of pieces of luggage allowed, baggage dimensions and weight. Airlines commonly require that checked luggage in economy class not exceed 50 lbs. with a combined length, width and height of 62 inches. Airlines usually allow one small carry on item. Airline policies regarding baggage vary and are subject to change at any time without prior notice. Each traveler bears responsibility to know the baggage policy of the airline that issued a ticket for their journey. Malone Clan Expeditions, LLC shall not be responsible for additional fees imposed by airlines related to baggage.

Additional fees may apply to passenger transfers for travelers exceeding standard international coach class air travel baggage restrictions as published by the airline provider.

TRAVEL DOCUMENTS:

A successful application to become a member of a journey as a fellow traveler presumes a passport valid for at least 6 months after journey conclusion. The traveler bears sole responsibility to verify expiration dates of passports or other travel documents. U.S. citizens and non-citizens may require visas in addition to a valid passport. It is the sole responsibility of non-citizens of the U.S. (including green card holders) to ensure they possess the required visas/travel documents for each country visited on their journey and for re-entry into the United States. Visa fees (if any) are not included in the price of the journey.

STATE DEPARTMENT/GOVERNMENT ADVISORIES:

From time to time, a government entity such as the U.S. State Department (www.state.gov), Center for Disease Control (www.cdc.gov), other United States government or foreign government agency, may issue a travel advisory, warning or alert for a destination or surrounding area you may be visiting while on your journey. Malone Clan Expeditions, LLC encourages you to refer to these agencies to obtain the most current and up-to-date information. The terms and conditions of your journey, including cancellation policies, cannot be altered based on any occurrence whatsoever and/or any travel advisory, warning or alert issued in the U.S. or foreign countries where your journey is scheduled to visit, including but not limited to war, terrorism, disease, or natural disasters. Cancellation penalties remain in full effect and no exceptions can be made.

Exclusive jurisdiction and venue for any and all disputes arising under, in connection with, or related to any and all services by provided by Malone Clan Expeditions, LLC or these General Terms and Conditions shall be in the state court sitting in Cape Girardeau County, Missouri. You expressly agree not to challenge the jurisdiction or venue of such court or to assert that such court is not a convenient forum. All disputes arising under, in connection with, or related to these General Terms and Conditions or the provision of goods, services or activities by Malone Clan Expeditions, LLC shall be governed by the internal laws of the State of Missouri, without regard to its conflicts of law provisions. Payment of deposits by journey participants indicates acceptance of the above General Terms and Conditions. The venue for any dispute is Cape Girardeau County, Missouri. The laws of the state of Missouri will apply.
